Commissioner Elizabeth (Betty) Buck called the meeting of the Maryland Alcohol, Tobacco and Cannabis Commission to order at 3:00 PM.

II. APPROVAL OF MINUTES

Commissioner Elizabeth (Betty) Buck called for a motion to approve the December 19, 2024, meeting minutes. Vice Chair Eric Morrissette made a motion to approve, which Commissioner Dourakine Rosario seconded. All members present voted in favor and unanimously approved the previous meeting minutes.

III. EXECUTIVE DIRECTOR REPORT

Director Jeff Herndon reported on the commission updates and enforcement activity for the month of December 2024.

a. Enforcement Activity

- Inspections
 - o In the month of December 2024, the ATCC's Field Operations Bureau (FOB) conducted enforcement activities, including One hundred, sixty-nine (169) alcohol inspections, and two hundred, fourteen (214) tobacco / cannabis inspections.
 - o Seven (7) of these inspections resulted in reportable incidents.
- Reportable Incidents: From these seven (7) reportable incidents, the FOB seized:
 - o Nineteen thousand, eight hundred sixty-three (19,863) sticks of OTP yielding a tax loss of \$13,904.00.
 - o Four hundred, fifty-one (451) packs of cigarettes yielding a tax loss of \$2,260.00.
 - o Seven (7) containers of alcohol yielding a tax loss of \$2.43.

b. Regulatory, Licensing and Administrative Services Division

- Nothing to report this month.

c. Legal & Legislative Division

- 2025 Legislative Session
 - o Agency Sponsored Bills
 - 1. THC Product Labeling Bill. Hearing is scheduled for January 30th.
