- a. Enforcement Activity
 - Inspections
 - o In the month of December 2024, the ATCC's Field Operations Bureau (FOB) conducted enforcement activities, including One hundred, sixtynine (169) alcohol inspections, and two hundred, fourteen (214) tobacco / cannabis inspections.
 - o Seven (7) of these inspections resulted in reportable incidents.
 - Reportable Incidents: From these seven (7) reportable incidents, the FOB seized:
 - o Nineteen thousand, eight hundred sixty-three (19,863) sticks of OTP yielding a tax loss of \$13,904.00.
 - o Four hundred, fifty-one (451) packs of cigarettes yielding a tax loss of \$2,260.00.
 - o Seven (7) containers of alcohol yielding a tax loss of \$2.43.
